The meeting opened at 5:32 pm with a devotion provided by Sarah.

Present: Kathy Robinson, Shauna Robinson, Lloyd Zimmel, Sarah Lonsdorf, Pat Erdman, Jim Von Rueden, Verlyn Oelke, Kelly Brown, Pam Hackbart, and Jeff Blomquist. Online: Chuck Johnson.

A motion was made and passed to accept the March 8, 2022 Council minutes.

Pastor's Report: No report was provided.

President's Report: A written report was provided.

Treasurer's Report: A written report was provided. We have \$22,375 in our General Fund.

Committee Reports:

Education/Youth: Education Elder is on a one year substitution by Member at Large.

Good Stewards: A written report was provided. 92 meals were served for the Community Dinner; the remainder went to Bridge Community.

Property: No written report was provided. The bathrooms in the quilting area are completed. This will allow for extra needed restrooms rather than changing the current designation of our bathrooms in the main hallway. The work on the air conditioning will begin within a couple of weeks. Our Sunday custodian is out temporarily, Dave Skola and Jim are coordinating fill in.

Worship: A written report was provided. Discussion took place about putting communion cards back in the pews. Our constitution requires members to commune once a year, and some of the other information available on the cards is nice to have when needed. Council decided it is okay to have them back in the pews. Discussion took place about how to continue collecting offerings during services. We are going to continue collecting the offering in the plate at the back of church, but will start offering the plate at the altar during the service in June.

Trust Fund: A written report was provided outlining the investment results and funds distributed this month.

A motion was made and carried to accept these reports.

Old Business:

- Memorial Fund Review There is no change to the priority order this month. Technology Fund is number one, Current Expense Fund is number two, and Sustainability Trust Fund is number three.
- In-person worship will continue, we ask you mask as you are comfortable and please watch online if you are ill. Pew ropes have been
 removed, but we ask that you continue to distance from others and be mindful of those who are masked and may have compromised
 health issues. Communion will continue as is for the time being. Please continue to be mindful of your church family.
- Transition update The Call Committee has interviewed one candidate and continues to work through the call process.
- We discussed the Good Neighbor Fund disbursement and are working on a policy to help guide our new pastor.
- We tabled the discussion on our Wedding Policy updates.
- The Parsonage lease extension is pending. No decision has been made.
- Little Scholars is looking to extend their contract with us. We will work with them to figure out terms. A second refrigerator is needed in the kitchen area. Property will look into purchasing a refrigerator that St. Stephen will share with them when needed. Council approved by vote to purchase a new refrigerator using funds from the Wanta Fund up to \$1500.
- The Council received a thank you from Little Scholars for all of the work that has been done to the building in recent months and the relationship they have shared with our congregation.
- We tabled our discussion on how to proceed doing nominations as a Council in the coming year.
- We have made progress on our meeting technology. Some of the equipment has been purchased and they will continue to finalize the equipment and process.

New Business:

- A motion was made and carried to approve March bills.
- Kathy and Shauna Robinson will be our representatives at the Synod Assembly. This was approved by motion and vote.
- Discussion took place on whether we need to update our constitution now that the Synod has passed a new constitution. It was decided we will not make any changes at this time.
- Council has agreed to update our office computers at this time. We are not looking at making any program changes on the computers, just updating them so they can handle improvements to the software and run more efficiently. We will use the Technology Fund to cover costs. Council approved this by motion and vote.
- Personnel Committee recommended that we do not go to using time cards for employees; Council agreed.
- As we go through the call process, we are starting to look at the Mutual Ministry Committee for our new pastor. We will start looking for people for that committee in the future.
- Jim mentioned we have some cupboards downstairs that have allowed contents to mildew. Council told Jim it was okay to go ahead and remove the cupboards.
- A motion was made and carried to use funds from the Wanta Memorial to re-key the church doors as needed up to the cost of \$1500.

Our next regular meeting is scheduled for Tuesday, May 10th at 5:30 pm with Lloyd providing devotions.

Meeting was adjourned at 7:30 pm with the Lord's Prayer.

Save on Prescription Drugs

United Way Worldwide is a partner with SingleCare (formerly FamilyWize), which offers discounts on prescription drugs. Last year residents of Marathon County saved \$32, 953 by using this program. Get your free SingleCare card. Print your card from SingleCare. Download the free SingleCare app on your smartphone. Start saving on your prescription drugs:

1) Start with a search: Look up prescriptions to find the lowest prices in your area. Click on a prescription to customize the dosage and quantity.

2) Get a free coupon card: Download, text, or email yourself a free SingleCare coupon card. It can be used at participating pharmacy locations, and it's completely free.

3) Save on your scripts: Show the coupon card to your pharmacist. They'll input the magic numbers from the card and your savings will be automatically applied.
