

St. Stephen Trust Fund

St. Stephen Lutheran Church established a Trust Fund in 1988 as an investment in our future. There are two funds invested through Financial First Advisors in Wausau. The Trust Fund Committee is responsible for these funds and uses only a percentage of the earnings for the designated projects. The Wider Mission Fund is to support the wider mission of the Church in our community and globally. Examples would include: The Neighbors' Place, Faith in Action, Open Door, the Wausau Warming Center, Homeless Kids Fund, Lutheran World Relief, and others. The Building Preservation Fund is for the preservation of our church buildings. In the past this has included fixing the elevator, parsonage updates, and organ repair as well as other repair projects. St. Stephen is known for its generosity. Because only the interest earned on each fund is used in our outreach missions, it is important to maintain a solid investment balance. Please keep the St. Stephen Trust Fund in mind when doing your estate planning. You can designate a specific fund or project, or make a general reference to the Trust Fund.

Shoe Drive

We have been invited to participate in a Shoe Drive to raise funds for youth attending the Youth Gathering in New Orleans. Donations of gently worn, used and new shoes will be accepted. We will be collecting shoes from now until May 2, 2024. For more information, please see the bulletin board near the church office, or ask Pastor Karoline or Shauna Robinson. The donation bin will be outside the church office next to the bulletin board! In the US alone, over 600 million pairs of shoes are thrown away per year. The materials used to manufacture a pair of shoes are created from chemical compounds that will create health hazards if left to disintegrate openly or in landfills. By donating your gently worn, used, and new shoes, your shoes are given a second chance to make a difference. All donated shoes will be redistributed to microenterprise partners through Funds2Orgs, a for profit social enterprise, and used in developing nations for impoverished people to start their own businesses.

PROPOSED 2024 PROPERTY REPAIR UPDATED RESOLUTION

Resolution #1

An opportunity has arisen to address the failing alley pavement in conjunction with our neighbors to the North of the alley as they plan for parking lot repairs adjacent to the alley. The pavement is heavily sunken due to years of use and large vehicles. The slope of the alley due to this condition prevents rainwater/snow-melt from draining away from church foundation and in the past has caused water intrusion. The work involved would be to remove the pavement and road base, re-build the road base, and add 2 layers of pavement with grading to divert water away from the church foundation. Costs would be shared with our neighbors and expected to not exceed \$12,000.

Be it resolved that St. Stephen Church work with neighboring properties to have the alley rebuilt with a cost to St. Stephen not to exceed \$12,000.

Resolution #2

Today we stream our Sunday services on Facebook and later post them on our website and have them run on local access television for our shut-in's and members that cannot make services. We routinely have 75+ views of our weekly service from our website. Our current video streaming equipment is approaching 15 years old. The cameras are standard definition and today we attempt to upscale the picture to near HD however the clarity is not very good. We would recommend upgrading the 3 PTZ (Pan/tilt/zoom) cameras, the controller, and the computer to support HD and 4K video streaming to our viewers. The expected cost is not expected to exceed \$10,000.

Be it resolved that St. Stephen Church purchase new HD cameras and associated equipment to improve the video quality of our broadcasts for our members viewing services externally. Costs not to exceed \$10,000.

Resolution #3

In February's Annual Meeting, the congregation approved repairs to the building (roof, tuckpointing, parapet caps, facia, louver replacement, and brick sealing, with costs expected to be \$203,700. A motion was made and carried to adjust the approved costs to \$215,000 allowing for possible overruns. The resolution called for utilizing \$26,000 from the Building Improvement Fund and \$24,000 from Building Preservation Trust Fund to reduce the borrowing cap to \$157,300. Minutes reflect borrowing to not exceed \$215,000, not an adjusted value of \$165,000.

As financing has not been finalized for the originally approved resolution, we would like to combine the financing of the 3 projects, which would result in an amount borrowed not to exceed \$190,000.

Payment of financed loan would be raised by a capital fund raising program within the congregation and utilizing funding from internal sources, such as the Building Improvement Fund, Building Preservation Trust Fund, and bequests/memorials as Council deems appropriate. Our goal would be to ensure that said bequests/memorials and trust accounts are not depleted and can continue to provide growth opportunities and coverage for unforeseen future events.

Be it resolved that St. Stephen Church finance the combined 3 projects for no greater than \$190,000 and at its discretion throughout the life of the loan, utilize existing Building Preservation Trust Fund and bequests/memorials monies in accordance with appropriate bylaws and giving guidance, to cover portions of the loan.

COUNCIL MINUTES ~ APRIL 9, 2024

The meeting opened at 5:30 pm.

A motion was made and passed to accept the March 12, 2024 Council minutes.

<u>Pastor's Report</u>: A written report was provided. Pastor Karoline discussed changes that have been happening at many churches since Covid, attendance is down by two-thirds, online attendance is growing, and the tone of the census was that of hope. Council discussed what they find hopeful. What do you find hopeful in your life?

<u>President's Report</u>: No written report was provided. We were all very happy with the great turn out of people at worship during Lent.

Treasurer's Report: Our General Fund currently has a balance of \$14,272.

A motion was made and passed to accept these reports.

Committee Reports:

Good Stewards: No written report was provided. We have been participating in a Shoe Drive to raise funds for ELCA youth attending the Youth Gathering in New Orleans. Donations of gently worn, used, and new shoes will be accepted from now until May 2nd. Contact Shauna Robinson with any questions.

Property: A written report was provided. If we partner with Dick Holster's property (formerly YWCA) and the law firm behind the church, the church will save approximately \$920 annually for garbage disposal (includes recycling). The dumpsters will be located across the alley. We have an opportunity to have the alley behind the church building blacktopped by Tito Excavating, with an estimated the cost of \$10,000. This item will be brought to the congregation for a vote. A special congregational meeting is scheduled for Sunday, May 5th. Temporarily, speakers have been added in the church, one on each side. The speakers were donated. It was also mentioned that the office computers should be provided with a UPS backup in case of power outages.

Worship: No written report was provided. The committee did not meet in March. Their next meeting is Thursday, April 11th. **Trust Fund:** The committee approved a request for \$400 for the Good Stewards Committee for the Community Dinner in April.

A motion was made and passed to accept these reports.

Old Business:

• Memorial Fund Order – There is no change to the order this month. Building Improvement and Maintenance Fund remains at number one, Current Expense Fund at number two, and Sustainability Trust Fund at number three.

New Business:

- A motion was made and passed to approve March bills.
- Safety Committee If you are interested in becoming a Safety Committee member, please contact Kathy Robinson.
- Capital Campaign Krause Konstruction has been contracted to complete the repairs to the roof. This will be discussed with the congregation in May. There are two financing possibilities, one suggestion is to borrow the money from the Trust Fund or borrow the money from an external source.
- Task Force update The Task Force is interested in what members of St. Stephen feel are our greatest values. Three of the values discussed were care of the congregation, care of the church and property, and help within our community.
- Annual Rummage Sale The 2024 St. Stephen Rummage Sale will be held on April 27th and 28th. Donations are currently being accepted. No large furniture will be accepted. Please contact Lynn Deffner or a member of Stephen's Angels for more information.
- Church Directory The last directory was completed in 2017. Further discussion of a new directory will be held in 2025.

The next Council meeting is scheduled for May 14th, 2024 at 5:30 pm.

Motion was made to adjourn the meeting at 7:45 pm.
