



IMPORTANT TAX INFORMATION

Checks and money must be delivered by hand or mail, and postmarked on or before December 31, 2024 in order to claim a charitable contribution deduction for 2024. Checks that are placed in the church offering at the first service of January 2025, WILL NOT QUALIFY FOR A CHARITABLE DEDUCTION IN 2024, even if the check was dated for 2024, or was actually written in 2024.

To ensure the deductibility of your church contributions, please do not file your 2024 income tax return until you have received a written acknowledgment of your contributions from the church. You may lose a deduction for some contributions if you file your tax return before receiving a written acknowledgment.

COUNCIL MINUTES ~ NOVEMBER 12, 2024

Present: Pastor Karoline, Dick Holster, Verlyn Oelke, Vicki Romang, Jeff Blomquist, Sarah Lonsdorf, Shauna Robinson, Darrin Koehler, and Jacque Schremp.

Absent: Kathy Robinson, Sue Holster, Lynn Deffner, and Nancy Prigge.

Dick Holster led the meeting in the absence of President, Sue Holster.

Council Minutes from October 8, 2024: A motion was made and carried to accept the minutes without any changes.

Pastor's Report: A recommendation was made to involve the younger members of the congregation by adding a noisy offering during Sunday services. The Annual Meeting is being planned for Sunday, February 9, 2025. It was recommended that St. Stephen be a sponsor for Crossways Camping Ministries. A day camp is tentatively being planned for June. The recommended locations are Rib Mountain State Park or Marathon Park. The Council approved sponsoring this event. Several updates have occurred or are in the process at St. Stephen: We mourned the deaths of Geraldine Schlamp, Jim Sekaney, and Delores Hilmerhausen. Currently, there are three young people from St. Stephen who are attending confirmation classes. A baptism is in the planning stage. A family has requested to join our worship family. Table talks have begun. The purpose is to have one-on-one talks with fellow members on subjects of interest. If you would like to attend a Table Talk session, a sign-up sheet is located in the reception area.

President's Report: A president's report was not provided for October.

Treasurer's Report: Our total capital is \$3,748. A line item on the balance sheet, Accts Rec-Little Sch Rent Receivable, to be reviewed. The Christmas Tree Fund to be combined with the Banner Fund.

A motion was made and carried to accept the reports.

Committee Reports:

Good Stewards: The Little Free Pantry has been utilized heavily. We are working together this Christmas season with Good Shepherd, Immanuel, and Pilgrim to sponsor 30 kids through the Adopt-A-Family program. Donations of wrapping paper and tape are welcome. Shauna Robinson will be available after services to coordinate this event.

Property: Two church window frames (large window with Jesus and children and a south window) are in need of repair. These frames will need to be rebuilt. The repairs may take up to a year to complete. An organ tuner was available to give an estimate of repairs/life of the organ. In the current condition, the life of the organ is expected to be 10 years. Future need of upgrade from pneumatic to electric control with an estimated cost of \$60,000. The last time the organ was updated was in the 1970's. Discussion was held on implementing solar energy that will decrease the electric bill considerably. There is a 30% tax credit for implementing solar. Checking into the possibility of grants available for non-profit organization to assist with the cost.

Trust Fund: Distribution of \$3,250 was approved for October and \$4,200 for November. Some programs that are utilizing the funds are Adopt-A-Family, Lutheran World Relief, Toys for Tots, Homme Home Building Improvement, Catholic Charities Warming Center, Little Free Pantry, and Wheels to Work program.

Worship: Advertisement of the service times is a combined effort with Good Shepherd and Pilgrim Church. The Council approved a budget of \$200. **Important events in December:** The Christmas tree will be decorated on Friday, December 6th, time is pending. **Services at St. Stephen:** The Choral Service will be held on December 8th, Candlelight Concert on December 20th at 6:30pm and 8:30pm, Christmas Eve Service at 4pm, and a combined Christmas Eve Service with Good Shepherd at 10:00pm. **Services at Good Shepherd:** Christmas Eve at 2pm and 5pm and a combined service with St. Stephen on Christmas Day at 10am. **Services at Pilgrim:** Christmas Eve at 5pm and Christmas Day at 9am.

A motion was made and carried to accept these reports.

Old Business:

 Memorial Fund Order – The Current Expense Fund is number one, Building Improvement and Maintenance Fund is number two, and Sustainability Trust Fund is number three.

New Business:

- The total amount of invoices paid in October was \$17,931.
- Capital Campaign The loan for the roof was budgeted at \$180,000. The amount needed to borrow is \$125,000. Approval was granted for a construction loan of \$125,000 with a monthly payment of \$1,459 for 10 years. Due to the contributions received the monthly payment may be lower than anticipated. Reminder to congregation contributors will be made by the committee.
- Taskforce Update Pastor Mode will talk with all involved Task Forces concerning the process of the consolidation/merger. She will
 discuss the major concerns previously indicated by the congregation. A Town Hall at St. Stephen will be held on Sunday, November 24th
 after the service.
- 2025 Budget The budget will be discussed with Council members on Sunday, December 1st after the service.
- Nominating Committee Dick Holster continues to find volunteers to fill the open Council positions. The Council Secretary position and two Member-At-Large positions are available. If interested, please contact Dick or another Council member.

The next Council meeting will be on Tuesday, December 10, 2024, at 5:30pm.

A motion was made to adjourn the meeting at 7:55pm.
