



Benevolence

This is the eleventh month of our unified budget in which we now give four and one half percent (4.5%) of our current expense receipts and loose plate offerings for benevolence. The above amount is based on the income of \$8,877 for November.

Capital Improvement Update

As of December 1, we have made payment to Krause Konstruction for the building work completed this summer.

As a refresher, here is what was completed, all items under budget:

- Alley repair \$3,533
- Video streaming equipment upgrade \$3,936.51
- Roof/tuckpointing/louvers/fascia repair \$201,633
- Total expenditures = \$209,132.51

With giving from the congregation and monies from both the Trust Fund and the Building Improvement fund, we ended up financing \$121,000 from the Mission Investment Fund of the ELCA.

Our monthly payments to pay off the loan in 5 years' time will be approximately \$2,415/month.

Thank you to those who have contributed financially in 2024 and made a commitment to ensure we are able to pay off the loan quickly. If you have yet to meet your 2024 commitment, please do so as soon as possible. If you have yet to complete a pleage form, they are available in the office and can be turned in at any time.

Don't forget 2025 is right around the corner and we will need your pledged funds starting in January to help us meet our monthly obligations.

If you need a reminder on your pledge amount, please contact the office and Mary Beth will provide you with the pledge amount.

IMPORTANT TAX INFORMATION

Checks and money must be delivered by hand or mail, and postmarked on or before December 31, 2024 in order to claim a charitable contribution deduction for 2024. Checks that are placed in the church offering at the first service of January 2025, WILL NOT QUALIFY FOR A CHARITABLE DEDUCTION IN 2024, even if the check was dated for 2024, or was actually written in 2024.

To ensure the deductibility of your church contributions, please do not file your 2024 income tax return until you have received a written acknowledgment of your contributions from the church. You may lose a deduction for some contributions if you file your tax return before receiving a written acknowledgment.

COUNCIL MINUTES ~ DECEMBER 10, 2024

Present: Pastor Karoline, Sue Holster, Dick Holster, Verlyn Oelke, Vicki Romang, Jeff Blomquist, Sarah Lonsdorf, Shauna Robinson, Darrin Koehler, and Lynn Deffner. **Absent:** Kathy Robinson, Nancy Prigge, and Jacque Schremp.

Jim Von Rueden has graciously volunteered to temporarily fill the role of Assistant Treasurer while Mary Beth Tolley is recovering from an illness. A motion was made and the Council unanimously approved this temporary transition.

<u>Pastor's Report</u>: A written report was provided. Pastor Karoline will be away January 7th thru the 19th for a continuing education opportunity. She will be traveling to Greece and Turkey and will be visiting many of the sites of Pauline New Testament epistles. During the month of November, we mourned the deaths of Jim Sekaney, Chuck Deffner, and Jerry Hoppe. Three Table Talks have been conducted. A couple of the topics that were covered were concerns over the future of our building and inclusion; how we can be more welcoming to others. Table Talks will continue with topics of concern. The noisy offerings will be included in the services the third Sunday of the month. Vicki Romang will provide several buckets to involve as many of the youngest members of our congregation during the service as possible.

<u>President's Report</u>: No written report provided. The Candlelight Concerts are filling up. There has been a great response for the concerts that will be held on December 20th and 21st.

<u>Treasurer's Report</u>: Our total capital is \$8,078. The rental income from the parsonage and Little Scholars is up to date.

A motion was made and carried to accept these reports.

Committee Reports:

Good Stewards: No written report provided. We are sponsoring 30 families through the Adopt-A-Family Program. All the tags have been picked up by congregation members. We have been asked to adopt three mothers in the area that are in great need. It is wonderful to see how we are able to help so many in our community. Over 100 meals were served during the Community Dinner held in November. This event will be held at First United in the future. Good Shepherd church is now joining the Good Stewards Committee in efforts to help the community.

Property: A written report was provided. The Property Committee, along with the support of the Trust Fund Committee, is looking to replace the double oven in 2025. Due to safety concerns, it is suggested starting in 2025 to replace the wax candles during the Christmas Eve services with LED candles. Window repair on the west side of the church has begun.

Trust Fund: A written report was provided. Distributions in the month of November totaled \$1,300. Recipients of the distributions were Crossways Camping Ministries, The Neighbors' Place, Fellowship of Christian Athletes, and The Women's Community.

Worship: A written report was provided. Advertisement of the times of our Christmas services is a combined effort with Good Shepherd and Pilgrim Churches. The total amount paid for the advertisement in the City Pages and Wausau Pilot and Review was \$752. This expense will be divided among the three churches.

A motion was made and carried to accept these reports.

Old Business:

• Memorial Fund Order – No change to the order this month. Current Expense Fund is number one, Building Improvement and Maintenance Fund is number two, and Sustainability Trust Fund is number three.

New Business:

- The total amount of invoices paid in October was \$101,484. This amount includes \$80,662 to Krause Konstruction for roof repairs.
- Capital Campaign Reminder to congregation contributors will be made by the committee.
- Task Force Update Many topics were discussed during the Task Force meetings. The two major concerns were what can we do together, a discussion with Pastor Mode, and what do we want to create through our ministry. Discussions in 2025 will include but are not limited to, the life cycle of the church.
- Nominating Committee Dick Holster has found volunteers for most of the open Council positions. The Council Secretary position is still available. If interested, please contact Dick Holster or another Council member.
- Annual Budget The submitted annual budget for 2025 was accepted by the Council with a few updates. A large expense in the budget is the weekly offering envelopes and the postage to send them. The approximate cost for the envelopes is \$3,682. This will be a topic to further discuss with the congregation.
- Pine Tree Quilters (PTQ) The PTQ group is interested in renting some space in our building. The group has been holding their meetings at Mount Olive for over 10 years. However, Mount Olive is not able to provide space any longer due to growth within their congregation and events.

The next Council meeting will be on Tuesday, January 14, 2025 at 5:30pm.

A motion was made to adjourn the meeting at 7:45pm.
