# Mother's Day Slide Show



Alleluia! Christ is risen! Christ is Risen indeed!

Happy Easter! Easter is so much more than a single day. The season of Easter lasts 50 days after Easter Sunday until we celebrate the Holy Spirit and beginning of the Church on Pentecost. Notice that Easter is 10 days *longer* than lent! Also, every Sunday and every time we gather to celebrate the resurrection is a mini Easter!



There is another sort of resurrection happening in Wausau, this time as an outgrowth of some endings and struggles. How we address homelessness in our area has long been an issue and how to best reach and support our neighbors. There have been numerous organizations and individuals who have gotten involved in serving and addressing the issue. Sadly, Catholic Charities has had to revert to a previous shelter model and will be closing the Good Shepherd Shelter at the Community Partners Campus from May-November, which leaves no overnight shelter in the area. This is due to logistics, not due to lack of need. In fact the need is increasing. This crisis has added fuel to ecumenical conversations about how congregations across denominations can work together to address these needs. The Wausau Police Department is opening a temporary shelter at First United Methodist Wausau to give space for longer term decisions to be made. St. Stephen, Good Stewards, and especially Shauna are deeply involved in conversations about how to faithfully act. This is the beginning of a new and exciting project! There are lots of ways to get involved, from volunteering to helping with a meal, to joining a conversation. Please pray for your church, your community, and your neighbors as we seek to do a new thing!

## Capital Improvement/Mission Investment Loan

In 2024, St. Stephen borrowed **\$121,000** from the Mission Investment Fund of the ELCA to finance building improvements. Beginning in early 2025, we began making monthly payments, with the goal of paying the loan off in 5 years' time. As of April 1st, our current balance is **\$119,600**. 

Pastor's Report: Pastor Karoline provided a written report.

**Treasurer's Report:** The General Fund total is \$18,454.73 and the total capital is \$9,257.30.

#### A motion was made and carried to accept these reports.

#### Committee Reports:

**Good Stewards:** A written report was provided. Tracy Rieger requested funding for rental assistance for a couple. In the future, representatives from Good Stewards will make decisions regarding these requests using funds from the Community Outreach Fund without needing Council approval.

**Property:** A written report was provided. The Property Committee will work toward labeling doors and windows at St. Stephen for safety purposes. A safety walkthrough may be performed by Wausau police in the future.

Trust Fund: A written report was provided from the April 6, 2025 committee meeting.

Worship: A written report was provided from the March 13, 2025 committee meeting.

#### A motion was made and carried to accept these reports.

Old Business:

• Memorial Fund Order – No change to the order this month. Current Expense Fund is number one, Building Improvement and Maintenance Fund is number two, and Sustainability Trust Fund is number three.

#### New Business:

- Invoice Approval—The total amount of invoices paid in March was \$29,724.39.
- A motion was made and carried to approve the paid invoices.
- Noisy Offering—April 20th
- Donations from the noisy offerings will continue to be added to the Community Outreach Fund.
- Capital Campaign—A reminder to fulfill pledges will be announced in church and placed in the Deacon's Spirit.
- Task Force—The Task Force will meet in May and will then take a hiatus before regrouping at a later date. The focus at this point is on continuing our shared ministry.
- Confirmation Approval—Confirmation will take place on May 18th at Good Shepherd.
- A motion was made and carried to approve Elizabeth Lenoble as a confirmed member of St. Stephen.
- First Communion—One student from St. Stephen will be participating in First Communion education on April 12th, along with students from Good Shepherd. First Communion will take place on Maundy Thursday.
- Lockers for the Homeless—The Marathon County Community Outreach Task Force has made a request to place four to six lockers outside of St. Stephen near the dumpsters, as a place for unhoused individuals to store their belongings.
- A motion was made and carried to approve the request for placement of the lockers, pending a check with St. Stephen's insurance carrier.
- Thrivent Webinar: Estate Preservation for the Next Generation—May 13th at 5:30 pm.
- Hosted at St. Stephen by Mandy Roberts from Thrivent. A meal will be provided.
- Synod Assembly—June 7th in Green Bay; two lay voting members are needed.
- Jim Von Rueden will attend staff meetings as Council representative.
- Goals for 2025—Review Constitution & Bylaws; review memorial funds; update membership list.

The next Council meeting will be on Tuesday, June 10, at 5:30 pm.

The meeting was adjourned at 7:20 pm.
