

A note on the combined services:

Many people have the tradition of attending a late night service on Christmas Eve or worship on Christmas morning, even if they are no longer connected to a congregation. Through collaboration we are able to offer a greater variety of services and worship times. Last year we experimented with offering a combined late service and we noticed that the majority of those in attendance were visitors not connected to either congregation. This year we decided to offer a shared late service planned by multiple congregations held at St. Stephen and to offer a community Christmas morning service at Pilgrim. Come join us! This is a great opportunity to invite neighbors, friends, and family!

Worship schedule for after Christmas: January & February

As we prepare for the merger of our congregations, we are taking the in-between time between Christmas and Lent to plan some combined worship services. These services are a short-term way to help us continue to get to know one another and to prepare us for joining together.

*December 28th: Combined service "Brunch Church" at Pilgrim. This will be in the fellowship hall with a breakfast potluck using the Sanctified Art Brunch Church Liturgy.

*January 18th: Combined worship at St. Stephen

*February 1st: Combined worship at Pilgrim

*February 15th: Combined worship at St. Stephen

On the Sundays we have combined worship, Pastor Karoline will lead the Thursday evening service at Pilgrim (with the exception of brunch church). That will be January 15th, January 29th, and February 12th.


Order of Importance of Memorials and Other Special Offerings

Secondary Funds: Bell Choir Fund, Brick Maintenance (tuck pointing), Choral Fund, ELCA Scholarship Fund, Good Neighbor Fund, Library Fund, Organ Fund, Quilters Memorial Fund, Parish House Alarm, Technology Fund, and WELCA Clean Water Fund.

Other Funds: Confirmation/National Youth Gathering, Faith Enrichment Fund, Major Church Improvement, Missionary Sponsorship, Rooted in Faith (Crossways Capital Improvement) Fund, Seidel/Meyer Scholarship, Seminary Scholarship, and World Hunger.





Present at meeting: Dick Holster, Jean Trempe, Pr. Cath Mode, Pr. Karoline Schwantes, Pam Hackbart, Jeff Kessel, Sue Koerten, Sarah Lonsdorf, Verlyn Oelke, Jim Von Rueden.

Our synod coach, Pr. Cath Mode, started the meeting. She reviewed our new Mission Statement that came out of the retreat on Oct. 26: "Walking Together to Celebrate Christ's Love." We should use this from now on in meetings and written communications.

Pr. Cath continued with a hymn, "Woke Up This Morning". We sang this together. This hymn was printed in a handout that includes a brief write-up on each verse incorporating a short quote from scripture. This handout can be used as a resource in the merger process. The very last sentence concludes with the sentence: Stirring The Pot. She reminds us that **Doing God's work stirs the pot.**

Dick read an email he received from a person who attended the retreat on Oct. 26. The email showed us the enthusiasm and excitement that can be generated by the work that the congregations are doing.

Pr. Cath presented a handout titled "Seven Stages of Congregational Grief and Loss". We were asked to draw an emoji representing where each of us is at today. Our emojis were discussed and followed with a discussion of the seven stages. At any given time, there will be congregation members in most or all of the stages. The members of the transition team may be in the same stage but stay aware that members of the congregations may feel differently.

Pr. Cath advised us to pray for Pr. Karoline and all our leaders daily.

A handout, "4 C's OF CONGREGATIONAL GRIEF", was read aloud and discussed in detail. Communal grief will be experienced as we go through the process. A grief support plan is essential. The four elements of support are Choose, Communicate, Connect, and Compromise. The handout will be made available to all leaders in our congregations. In summary Pr. Cath stated that the main job of leadership is dealing with the grief that will occur.

Should we have a timeline for tasks or events in the merger process? Pr. Cath stated: I encourage you to not set a timeline. If, for example, someone asks about Easter, we can say that by Easter we will be well into the transition.

Our most immediate task: Pr. Cath indicated that the first step is to be sure that the constitution is 100% done before we proceed.

WORK GROUPS.

- Ten work groups were proposed at the last Transition Team meeting. The groups are: Legal; Constitution and Bylaws; Real Estate with a focus on physical plant, grounds, and maintenance; Real Estate with a focus on long term uses for Pilgrim's property; Finance; Policies and Practices; Communications; Worship; Ministry (outreach, education, and evangelism); Celebration Team.
- Another work group was proposed at this meeting: A Prayer Work group. The function of this work group was discussed.
- **Getting the work groups started.** After much discussion it was decided that Dick, Jean, and Sarah will meet to come up with a spreadsheet of 11 work groups and present this at the next Transition Team meeting on the 18th. The spreadsheet should include:
- A recommendation on how many people there should be in each work group.

TRANSITION TEAM MINUTES CONTINUED

- The functions of each work group.
- A list of people who have volunteered to date for each of the work groups.
- We agreed that when each group first meets, the members should select a chairperson or co-chairs.
- It was suggested that 4 members of the combined Worship Team serve as the Worship work group. There was another suggestion: allow for two at large members. These at large members would be two congregation members not on the worship team who are interested in the process.
- The spreadsheet will be presented to the Transition Team for discussion and final approval at our next meeting on 11/18.
- The completed spreadsheet will be sent to both congregations.
- Following distribution of the spreadsheet let's plan for a "**coffee cake retreat**" after a service at Pilgrim and St Stephen. At these coffee hours we can present details about the work groups and recruit additional work group members.
- We envision a work group kickoff event later.

Discussion points during the meeting:

- Continue to be inclusive. This includes consideration of members with mobility problems: We are walking together; we are rolling together.
- We informed Pr. Cath that we will publish Transition Team Minutes in our bulletins and monthly newsletters.
- There was general agreement that there are important reasons for keeping the name St. Stephen for the merged congregation.
- Pr. Cath recommended that Pilgrim have heart to heart discussions about closure.
- Pr. Cath recommended that we need a tangible symbol such as a gift to show that we are all part of the merger.
- Pr. Cath advised us to consider the legal requirement that we have worship services or other programs frequently enough to maintain legally exempt status.
- Think about more items for the agenda for our next meeting.

Next Meeting: A Zoom meeting on November 18th.

Pr. Cath concluded the meeting with a blessing.

IMPORTANT TAX INFORMATION

Checks and money must be delivered by hand or mail, and postmarked on or before December 31, 2025 in order to claim a charitable contribution deduction for 2025. Checks that are placed in the church offering at the first service of January 2026, WILL NOT QUALIFY FOR A CHARITABLE DEDUCTION IN 2025, even if the check was dated for 2025, or was actually written in 2025.

To ensure the deductibility of your church contributions, please do not file your 2025 income tax return until you have received a written acknowledgment of your contributions from the church. You may lose a deduction for some contributions if you file your tax return before receiving a written acknowledgment.

COUNCIL MINUTES ~ NOVEMBER 6, 2025

Council Minutes for October 14, 2025: A motion was made and carried to accept the minutes without changes.

Pastor's Report: Pastor Karoline provided a written report.

Treasurer's Report: The total capital is \$23,708.96.

A motion was made and carried to accept these reports.

Committee Reports:

Good Stewards: A written report was provided.

Property: No written report was provided. A section of sewer line was replaced in the basement. Risers in the stairwell are being painted on Sunday. Agreements for snow removal have been made with the same providers as last year.

Worship: No written report was provided.

Trust Fund: A written report was provided from the November 5, 2025 committee meeting.

A motion was made and carried to accept these reports.

Old Business:

• Memorial Fund Order – No change to the order this month. Current Expense Fund is number one, Building Improvement and Maintenance Fund is number two, and Sustainability Trust Fund is number three.

New Business:

- Invoice Approval—The total amount of invoices paid was \$25,108.03. A motion was made and carried to approve the paid invoices.
- Noisy Offering—November 16, 2025: Donations from the noisy offerings will continue to be added to the Community Outreach Fund.
- Capital Campaign Update—Double payment was made in October. Capital Campaign 2024 fund balance is \$15,083.92.
- Transition Team Update—The Transition Team has continued to discuss work groups for the merger with Pilgrim. The next meeting will take place on November 18th.
- Wausau Area ELCA Church Presidents' Meeting—The next meeting will take place on November 18th.
- Community Outreach Fund—A request for funds for a security deposit was made to Laurie Sturzenegger from Good Shepherd.
- Combined Congregational Retreat—October 26, 2025: The group chose the following purpose statement: Walking Together to Celebrate Christ's Love! Work will continue on a statement of values.
- Bulletins—The Council continued to discuss printing the readings in the bulletin each week and will revisit this topic next month.
- Child Safety Plan—This topic will be addressed by a work group as part of the merger with Pilgrim.
- New Member Welcome—A New Member Welcome will be held during the first quarter of 2026.
- Family Christian Education—This topic will be addressed by a work group as part of the merger with Pilgrim.
- Budget—A proposed budget for 2026 was presented for review.
- Work groups—A table talk will be held following worship on November 16th to discuss work groups for the merger with Pilgrim. Individuals will have the opportunity to volunteer for work groups at that time.
- Advertisements for the December choral service and Christmas service will be placed in the Wausau Pilot and Review and on Facebook.

The next Council meeting will be on Tuesday, December 9, at 5:30 pm.
