WALKING TOGETHER TO CELEBRATE CHRIST'S LOVE

Epiphany, January 6th, celebrates the arrival of the magi, bringing gifts to the holy family. It is thought that it took them years to arrive, not just the 12 days of Christmas that we celebrate in the church year. Which makes sense, because that must have taken a whole lot of walking to follow the star. They came from the east, made a stop in Jerusalem before heading to Nazareth, and then walked home. This ancient road trip also led to Mary and Joseph fleeing to Egypt to protect young Jesus. It doesn't say in the Bible *how* they traveled, but we know it would have been an arduous journey.



And there is a lot more walking in Jesus's story. A visit to John the Baptist, walking into the wilderness, the travels of his itinerant preaching and ministry, his final walk to Jerusalem, and even his post-resurrection walk to Emmaus. Imagine if they'd had a Fitbit to tally all of those steps!

I know that I'm taking walking quite literally here. In the ancient world, there was a lot of walking, but there were also many modes of travel. And then, as now, there were many who could not walk, or found it difficult. The Gospel does not exclude them or their experience. The abundance of travel does show up in the story too. Early Christians known as people of The Way. They were followers, taking their own journeys to spread the news of the resurrection and the promise of grace. It was not about a destination, but about walking together in faith.

This theme runs deeply in the Old Testament too. The prophets speak warning to a people about to be conquered and taken into exile. But they also speak words of promise about God's grace and that there will be a way forward. Isaiah speaks about making a way in the desert, God smoothing the path.

Isaiah 40:3-5

A voice cries out:

*"In the wilderness prepare the way of the LORD;
make straight in the desert a highway for our God.*

*Every valley shall be lifted up,
and every mountain and hill be made low;
the uneven ground shall become level,
and the rough places a plain.*

*Then the glory of the LORD shall be revealed,
and all flesh shall see it together,
for the mouth of the LORD has spoken."*

These are promises for us too! Not that we won't find difficulty and conflict along our way (goodness knows, Grand Avenue is not a good example of a *smooth* path!) but there will also be lots of joys as well. Some opportunities to live this out will be in our upcoming shared worship services with Pilgrim during Christmas and the season after Epiphany. Watch the calendar! We will worship together, in each other's spaces. We don't move toward a specific destination, but we walk together in faith, trusting that God is with us!

We journey together to celebrate Christ's love.

Benevolence

Through your support of St. Stephen in the month of November 2025, we were able to contribute to the following ministry:

ELCA National & Synod Support \$554

This is the eleventh month of our unified budget in which we now give four and one half percent (4.5%) of our current expense receipts and loose plate offerings for benevolence. The above amount is based on the income of \$12,307 for November.

Secondary Funds: Bell Choir Fund, Brick Maintenance (tuck pointing), Choral Fund, ELCA Scholarship Fund, Good Neighbor Fund, Library Fund, Organ Fund, Quilters Memorial Fund, Parish House Alarm, Technology Fund, and WELCA Clean Water Fund.

St. Stephen Trust Fund

St. Stephen Lutheran Church established a Trust Fund in 1988 as an investment in our future. There are two funds invested through Financial First Advisors in Wausau. The Trust Fund Committee is responsible for these funds and uses only a percentage of the earnings for the designated projects. The Wider Mission Fund is to support the wider mission of the Church in our community and globally. Examples would include: The Neighbors' Place, Open Door, the Wausau Warming Center, Lutheran World Relief, and others. The Building Preservation Fund is for the preservation of our church buildings. In the past this has included fixing the elevator, parsonage updates, and organ repair as well as other repair projects. St. Stephen is known for its generosity. Because only the interest earned on each fund is used in our outreach missions, it is important to maintain a solid investment balance. Please keep the St. Stephen Trust Fund in mind when doing your estate planning. You can designate a specific fund or project, or make a general reference to the Trust Fund.

TRANSITION TEAM MINUTES ~ 11/18/2025

"Walking Together to Celebrate Christ's Love."

Present at meeting: Jean Trempe, Pr. Cath Mode, Pr. Karoline Schwantes, Charlie Freiberg, Pam Hackbart, Jeff Kessel, Sue Koerten, Sarah Lonsdorf, and Verlyn Oelke.

Our synod coach, Pr. Cath Mode, started the meeting with a devotion and a prayer. She reviewed our new Mission Statement that came out of the retreat on October 26th: **"Walking Together to Celebrate Christ's Love."** From now on we should include this on all written communications.

Update for Pr. Cath on how the process has been going since we met last. Comments we've received convey support for and excitement about the transition. Both congregations have more volunteers for the work groups.

Values: Jean Trempe shared the list she compiled for Pilgrim. There is no formal list of values for St. Stephen. Pr. Karoline shared a document listing the mission statement and list of values that came out of the combined retreat on October 26th. Pr. Cath suggested that we get about 4 people together in the next month to come up with a values document that can be posted.

WORK GROUPS

- Pr. Cath stated that we need to pare down our work groups. One option is to appoint task forces within a work group; each task force will be given specific charges. Another option is to ask some group members to move to another group based on their interests.
- We need to finalize our list of work groups. To that end we discussed Jean Trempe's revision of the spreadsheet.
- **Start-up of work groups** was discussed. The consensus was to start the groups this month and into next. The logistics of this process was discussed and potential complications with all that's going on during Advent and Christmas. It was decided to have a big get together in January where all the group members will be installed.
- Pr. Cath advised that we diligently proceed with the merger process without pause even in this busy season.
- **How to get the work groups started.** We agreed that a Transition Team member will facilitate the process of getting a work group off and running before January. One person referred to this role as the connector. We assigned this role for each of the work groups. Here's a list of the assignments:
 - Constitution/Bylaws: Verlyn Oelke
 - Legal: Dick Holster
 - Financial: Jim Von Rueden
 - Pilgrim's Real Estate (physical plant, Grounds, & Maintenance): Jim Lenselink
 - Pilgrim's Real Estate (long term use): Jean Trempe
 - Communications: Jeff Kessel
 - Policies & Procedures/Practices: Jeff Kessel
 - Worship: Sarah Lonsdorf
 - Ministries: The organization of this work group was discussed in detail. It was suggested to divide the group into two: Outreach and Inreach. Pam Hackbart will shepherd the Outreach group. Jean Trempe will recruit a person to shepherd the Inreach work group.
 - Prayer: Pam Hackbart
 - Celebration: Karen Larson
- Jean Trempe will update the spreadsheet to reflect the things we talked about in this meeting.
- Pr. Cath recommends that the Transition Team member facilitating work group start-up provide the work group members our new mission statement, a list of our values, an updated spread sheet, and the theme prayer for the transition.

Discussion points during the meeting:

- In our work towards merger an aim should be to attract the church and dechurched.
- The work group kick-off should include a liturgical beginning.
- Pr. Cath suggested that we incorporate a symbol/logo/design into our mailings and postings. A good place to start a search for a symbol/logo/design is to check out clip art available on the internet. This symbol/logo/design could be put on a card in the pews to remind people of the merger.
- We should craft a theme prayer for the transition. Sarah Lonsdorf will draft that.
- Another way to keep merger in people's thoughts is to post photos. Some photos of the retreat have been posted at St. Stephen.
- Congregational members are getting to know each other better. The whole process that we are in is 'Joyful Chaos'.
- We need to better define evangelism.
- A person from the synod may be part of the Constitution/Bylaws group work.

Pr. Karoline led us in prayer for a recently hospitalized Pilgrim member and a recently injured St. Stephen member.

Next Two Meetings:

- December 2nd, 3:00 PM, at St. Stephen. Transition Team members shepherding each work group are to give an update on the work group.
- December 16th. Agenda items to be determined.

Pr. Cath concluded the meeting with a blessing.

Present at meeting: Dick Holster, Jean Trempe, Pr. Karoline Schwantes, Verlyn Oelke, Charlie Freiberg, Pam Hackbart, Sue Koerten, Frank Koerten, Sarah Lonsdorf, Jim Von Rueden, and Jeff Kessel.

Verlyn Oelke, started the meeting with our new Transition Prayer. He and Sarah Lonsdorf met recently to compose this prayer. The team likes this prayer.

Transition logo/design: At our last meeting Pr. Cath suggested that we incorporate a symbol/logo/design into our mailings and postings. Jeff Kessel found a design online that he presented to the team in an email. Since then, Pr. Karoline suggested some modifications that incorporates our Mission Statement. This was discussed and there was general agreement that we like the design. This new logo will be tweaked. Nancy Henke will add this to St. Stephen’s bulletin and it will be added to Pilgrim’s bulletin. It should be added in the signature line of written communications.

(Core) Values:

- Jean Trempe shared the list she compiled for Pilgrim. There is no formal list of values for St. Stephen. Verlyn Oelke found an old list of St. Stephen’s values. Pr. Karoline shared a document listing the mission statement and list of values that came out of the combined retreat on October 26th. These lists are briefly reviewed.
- These lists of core values will be revamped by Pr. Karoline and attached to these minutes for release to the congregations.
- Transition team members assigned to work with the work groups is to present a list of values to each work group and report that the Transition Team is working on refining the list.

Evangelism: The definition of evangelism that was submitted to the team was briefly discussed.

WORK GROUPS

- Before the team meeting Jean Trempe updated the Merger Exploration work Groups spreadsheet and the Merger Exploration- Work Group Contacts list.
- Copies to the Contacts list were passed out and discussed.
- Verlyn Oelke reports that a pastor recommended the Synod office will serve as a resource for the Constitution & Bylaws work group.
- None of the work groups have met yet.
- Each Transition Team point person should contact the prospective work group members and schedule a meeting before the end of the month.

Constitution, Bylaws and Governance were discussed in detail.

- Verlyn Oelke reports that the ELCA has legal requirements about governance in addition to a new model constitution.
- Now that a Synod person will serve as a resource or consultant to the Constitution & Bylaws work group, we can address some issues. Some of these issues were discussed in detail. These include:
 - A timeline for the merger process that conforms to ELCA requirements.
 - 2026 budgets.
 - Merged council structure and composition.
 - A process for membership transfer during the merger process.
- Verlyn will be in contact with the person who will be our resource.
- Related to a timeline for the merger process the issue of our upcoming annual congregational meetings came up. Should we ask our congregations for further approval of the process? It was agreed that we consider presenting a resolution at the annual meetings. The team will be working on a resolution. Also, Pr. Karoline will consult a few people with experience in the process of merging. We set ourselves a deadline of 12/9 for coming up with a resolution.

Discussion points during the meeting:

- **We are thankful for all the people who want to be part of the process of merging.**

Our next meeting will be on January 5th at St. Stephen starting at 3:00 PM.

We concluded the meeting with the Lord’s Prayer.

Checks and money must be delivered by hand or mail, and postmarked on or before December 31, 2025 in order to claim a charitable contribution deduction for 2025. Checks that are placed in the church offering at the first service of January 2026, **WILL NOT QUALIFY FOR A CHARITABLE DEDUCTION IN 2025**, even if the check was dated for 2025, or was actually written in 2025.

To ensure the deductibility of your church contributions, please do not file your 2025 income tax return until you have received a written acknowledgment of your contributions from the church. You may lose a deduction for some contributions if you file your tax return before receiving a written acknowledgment.

Council Minutes for November 6, 2025: A motion was made and carried to accept the minutes without changes.

Pastor's Report: Pastor Karoline provided a written report.

Treasurer's Report: The total capital is \$26,441.69.

A motion was made and carried to accept these reports.

Committee Reports:

Good Stewards: Adopt-a-Family is ending this week. Gifts were purchased for 20 kids and 8 families. A wrapping party will take place on Saturday, December 13th.

Property: Re-covering of the stairs has been completed and a new entrance mat installed. A heat pump for the education unit was replaced. The Property Committee has made a recommendation to Little Scholars to discontinue using a shared passcode for the entrance beginning on January 3rd.

Worship: A written report was provided from the November 13, 2025 committee meeting.

Trust Fund: A written report was provided from the December 7, 2025 committee meeting. **A motion was made and carried to approve the four distributions noted in the report.**

A motion was made and carried to accept these reports.

Old Business:
